



Libyavoyager Privacy Policy

Your privacy is important to Libyavoyager. This privacy statement provides information about the personal information that Libyavoyager collects, and the ways in which Libyavoyager uses that personal information.

Personal information collection

Libyavoyager may collect and use the following kinds of personal information:

- Information about your use of this website;
- Information that you provide using for the purpose of registering with the website;
- Information about transactions carried out over this website;
- Information that you provide for the purpose of subscribing to the website services (if any);
- Any other information that you send to Libyavoyager.

Using personal information

Libyavoyager may use your personal information to:

- Administer this website;
- Personalize the website for you;
- Enable your access to and use of the website services;
- Supply to you services that you purchase;
- Send you statements and invoices;
- Collect payments from you; and
- Send you marketing communications.

Where Libyavoyager discloses your personal information to its agents or sub-contractors for these purposes, the agent or sub-contractor in question will be obligated to use that personal information in accordance with the terms of this privacy statement.

In addition to the disclosures reasonably necessary for the purposes identified elsewhere above, Libyavoyager may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, and in order to establish, exercise or defend its legal rights.

Use of cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.



You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

Securing of your data

Libyavoyager will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information.

Libyavoyager will store all the personal information you provide on its secure servers.

Information relating to electronic transactions entered into via this website will be protected by encryption technology.

Cross-border data transfers

Information that Libyavoyager collects may be stored and processed in and transferred between any of the countries in which Libyavoyager operates to enable the use of the information in accordance with this privacy policy.

In addition, personal information that you submit for publication on the website will be published on the internet and may be available around the world.

You agree to such cross-border transfers of personal information.
